**Contract Terms and Conditions**

- 1.) A non-refundable deposit of \$100.00 is required to secure the services as described above. Terms of this contract are not bound unless signed by both parties.
- 2.) Contractor of this event agree to furnish a safe and appropriate working environment. This includes but is not limited to providing a reliable power source within twenty-five feet of the work area; providing a facility that completely covers and protects the equipment and staff from adverse weather conditions (rain, direct sunlight).
- 3.) The balance due must be paid for in full by check, cash, or money order on or before the completion of the above described services. If the balance is not received by this time, all further obligations of Jae-La Entertainment will be excused, but the contractor obligation to pay the balance owing will remain in full force and effect. Canceled checks are subject to a \$30.00 service charge.
- 4.) Any time requested after the above scheduled time will be considered overtime and will be charged at a rate of \$75.00 per hour.
- 5.) In event an Act of God prevents services from being provided that are called for in this contract, damages will be limited to the return of the deposit. In all other circumstances, liability is limited to the cost of services. In no event shall Jae-La Entertainment be liable for any other damages including but not limited to: incidental damages, consequential damages, and damages for mental anguish and distress.
- 6.) The sponsor(s) will be held responsible for payment in full as stated above as well as for any damages incurred by Jae-La Entertainment while at the above event.
- 7.) **Cancellations** within thirty days of the event are subject to payment in full, unless the date and time are re-booked.
- 8.) Jae-La Entertainment reserves the right to cancel or postpone any events deemed unsafe or hazardous. The representatives of the sponsor must be at least eighteen years of age and will be responsible for fulfillment of this contract and warrants that he or she is authorized by the sponsor to execute this agreement on behalf of the sponsor.
